# Postgraduate Scholarship for Students Displaced from Belarus, Russia, and Ukraine 2024/25

- The Postgraduate Scholarship for Students Displaced from Belarus, Russia, and Ukraine is available for academic year 2024/25, for students from Ukraine, Russia and Belarus who are displaced and/or at risk of persecution, violence and conflict.
- The scholarship is open to students studying a masters degree starting in October or November 2024, with priority being given to STEM subjects, in particular maths and physics.
- One scholarship place is available in 2024/25. The scholarship award of up to £30,000 will comprise a full tuition fee waiver and a living costs bursary, for a maximum of 3 years.
- The Open University is working in partnership with King's College London. King's College London is the lead coordinating partner and grant holder for this fund.

- Please note: There is a maximum of 1 award available for 2024/25. Fulfilling the eligibility criteria does not guarantee you success. - be enrolled or intending to enrol on an Open University masters qualification starting in the 2024/25 academic year, starting study in October or November 2024
- · meet the entry requirements of your chosen masters degree
- be studying a minimum of 60 credits per academic year
- complete the qualification in no more than 3 years
